## Boarding Agreement

1. All animals must be current on all vaccinations including: Rabies, Distemper (D-H LPP or DAPP), Parvovirus, and Bordetella (kennel cough). Proof is required before entering property. Any known allergies \_\_\_\_\_
2. While we recommend flea/tick preventative, it is not required. If we find evidence of external parasites (fleas, ringworm, ticks, etc.) Old Highway Dog Boarding will be forced to quarantine your pet and you will be immediately contacted.
3. During the school year, check in time is from 5 am to 7 am and check out time is 5 pm to 8 pm. Summer hours check in will be 6 am to 9 am and check out will be 5 pm to 9 pm. Weekend hours will be from 6am-9pm year-round. Other times available upon request with prior notification.
4. Our facility has almost 2 acres of fenced area for dogs to run and play. There will be a minimum of 3-4 exercise/play sessions per day. We make every effort to provide socialized play for a more enjoyable stay. We will take every precaution to ensure the safety of all dogs. However, just like children on a playground, your dog may get bumped, bruised, scratched, etc. Do you consent to supervised socialized play? **YES**\_\_\_\_\_ **NO**\_\_\_\_\_ If yes, you agree that Old Highway Dog Boarding is not liable for minor incidents arising from group play. **Initials** \_\_\_\_\_
5. You must provide food for your dog and any extra bedding or blankets. Unless other arrangements are made, we will feed all dogs twice per day. We will provide a raised cot in each kennel, filtered water, bowls, and various toys.
6. We are not a grooming facility. We do not regularly bathe dogs during their stay, however, if the need arises for us to spot clean or wipe your dog off, do we have your permission? **YES**\_\_\_\_\_ **NO**\_\_\_\_\_

7. Media release. We have video security monitoring indoor kennel. We may also occasionally take photos of your dog. With your permission we would like to potentially use these for promotional/advertising purposes in print and social media. Do we have your permission? **YES** \_\_\_\_\_ **NO** \_\_\_\_\_
8. In the event your pet needs medical attention we will make every effort to contact you. In the event of an emergency, your pet's health is of the utmost importance. We will attempt to take your pet to the vet of your choosing. You, pet's owner, will be financially liable for all medical and transportation expenses.

9. We will only release your dog to the person that signs this agreement as the "Owner". You may designate other pick up persons \_\_\_\_\_
10. In the unfortunate event that your dog bites a person, you will be liable for all medical expenses. We are bound by all state and local laws regarding reporting of biting incidents.
11. We ask that if you must cancel, please give us at least 48 hrs notice.
12. Payment is due upon check out. No exceptions. Our charges are based on calendar days. Example: Drop off any time on Friday and Pick up any time on Sunday is 3 days. We do this for several reasons. Any time a dog is in a kennel we must go through an extensive cleaning and sanitizing process. Also, this allows us to have flexible drop off/pick up hours. We can provide either a paper or electronic invoice at any time. Any questions, PLEASE ask. For your convenience we accept: Cash, Personal Checks, and Credit/Debit cards (via Square). There will be a \$35 fee for any insufficient fund checks.
13. Old Highway Dog Boarding L.L.C. reserves the right to refuse service to any animal, at any time, for any reason.
14. We are licensed by the Iowa Department of Agriculture & Land Stewardship as a Commercial Kennel. As such, we must adhere to all laws and guidelines. Our license information is available upon request.
